The meeting was called to order by Mayor Weatherwax

A motion was made by Brent White to dispense of the reading of February 6, 2017 and February 13, 2017 minutes and to approve them. The motion was second by Joyce Jeffreys, with all voting in favor.

Mayor Weatherwax seeing that David Cannon was present from Republic Services called on him to speak about services that they could provide to the City. After a brief discussion between council members a motion was made by Jason White for Lawrence County Solid Waste to proceed with necessary paperwork to become exclusive provider at which time the matter will be brought back before the council to make a decision, the motion was seconded by Brent White with all voting in favor.

At last meeting a discussion about forming an Industrial Relations Board was presented. Mayor Weatherwax realizing that a previous board had been formed years ago for the purpose of a bond for purchasing land for an Industrial Park and not for recruiting informed the Council Members and others that he would contact old members and look at possibly changing duties of said board when members were confirmed.

A motion for Jackie Burch to contact Coffey Construction to continue dirt work when weather permits was made by Brent White and seconded by Jason White with Denise Lovett requesting that if cost begins to be foreseen to be in excess of the agreed upon \$10,000.00 to \$20,000.00 cost that Jackie Burch would come back to council before proceeding. All members voted in favor.

Joyce Jeffreys was called on by Mayor Weatherwax to speak about improvements to the City Cemetery landscaping, she spoke of improvements being needed to make the cemetery look nicer especially since the price of lots has been increased. After a brief discussion all members agreed to allow Joyce Jeffreys and Mayor Weatherwax to meet and talk about the type of improvements and possible candidates to make the improvements and bring back to the Council at a later date.

The Clerk Conference will be held in Hoover, Alabama on March 29, 30, and 31st and the motion was made by Denise Lovett and seconded by Joyce Jeffreys for Deroma Pepper, City Clerk to attend those meetings.

With no further business Mayor Weatherwax stated the next Council Meeting would be held on March 06, 2017 @ 5:00 pm and the next scheduled Work Session would be held on March 13, 2017 @ 5:00 pm.

Motion to adjourn was made by Denise Lovett and second by Joyce Jeffreys, with all voting in favor.
