CITY COUNCIL MEETING

The meeting was called to order by Mayor Roger Weatherwax. A motion for approval to dispense reading of the minutes for June 5 & June 12 meetings was made by Joyce Jeffreys and seconded by Brent White.

Mayor Weatherwax presented council with an: "Agreement between City of Moulton and Dwayne McKelvey and Chris Dean" to place signage at Deer Run Golf Course for 10 years with option to renew for 10 years. A motion was made by Brent White and seconded by Jason White with all voting in favor as long as the agreement is in compliance.

Disc Golf was introduced to the council at an estimated cost of \$7,780.00 - \$9,780.00 by Jackie Burch with Park and Receptions the workers at the park will do the install of the equipment by which will be a savings to the City. A motion was made by Joyce Jeffreys to purchase needed equipment and seconded by Jason White, with all voting in favor.

The Hillsboro Pipeline is in need of additional pipeline footage to make the connection complete at a cost of \$10,500.00 per contractors so Mayor Weatherwax ask for a motion to approve the additional cost. A motion was made by Brent White to approve cost and seconded by Jason White with all council in agreement but also stating that these items should have been included in original cost estimate approved originally and they felt like it was misrepresented to them by previous administration.

Mayor Weatherwax made Council aware of upcoming training for CMO 2017 and ask that they notify him if any would like to attend.

Applicants who applied for Building and License Inspector/Code Enforcer where ask to be present to be interviewed after regular business of the Council. The Council had taken into consideration 19 applicants and narrowed the choices to 7 to be interviewed. Mayor Weatherwax read a brief statement to all applicants then ask that they leave the room and be called back one at a time to be questioned by Council in alphabetical order. Those interviewed: Kenneth Dwane Fortenberry, William Thomas Glenn, Jerry Glen Johnson Jr., Jimmy Edward Kiker, Jason Merrell Norwood, James Renay Saint, and James Dwight Vanderford. Each applicant was ask the same questions and Council and Mayor took notes and will at a later time decide next steps in the hiring process.

There being no further business the motion was made to adjourn by Brent White and seconded by Joyce Jeffreys with all voting in favor.
