CITY COUNCIL MEETING

Mayor Weatherwax called the meeting to order and asked for a motion to dispense reading of minutes of November 20, 2017, December 4, 2017 and December 18, 2017 and approve them. Motion to approve minutes was made by Jason White, seconded by Joyce Jeffreys, with all voting in favor, motion carried.

Mayor Weatherwax presented Council with the Water Plant low chemical bids of Alum @303.00/Ton by Harcros, KmNO4 @3.45/Ton by Philtech, [PO4@.725/lb](#) by Philtech, Chlorine @ 594.00/Ton by Harcros, and Lime @ 182.20 ton by Carmuse. A motion to accept the low bids as stated was made by Brent White, seconded by Denise Lovett, with all voting in favor, motion carried.

Mayor Weatherwax then presented the Council with a request for approval for Jackie Burch to attend the Alabama Recreation and Parks Association Annual Conference January 28-30, 2018 in Tuscaloosa, AL at cost of \$250.00. A motion to approve attendance for Jackie Burch was made by Brent White, seconded by Jason White, with all voting in favor, motion carried.

Mayor Weatherwax called for an action from the Council regarding the Opioid Class Action law suit that local attorney Mark Dutton addressed the Council representing Levin, Papantionio, Thomas, Rafferty & Proctor PA, at the November 20, 2017 council meeting. After brief comments by Joyce Jeffreys, a motion to adopt Resolution 2018-001 was made by Joyce Jeffreys, seconded by Jason White. A roll call vote was taken, with all voting in favor, motion carried.

Renay Saint, Building Inspector, presented a report on Nuisance Notices from November 2017 to the Council. He then addressed each property listed, the current status with recommendations, as per attached. Not included in the report but discussed were properties at 11 Campbell Street and 709 Priest Street. Mr. Saint stated that these property owners will be contacted to encourage them to complete abatement of nuisances. He also mentioned the possibility of local Church participation by volunteering to help with clean up, if property owners will accept the help. Jason White questioned the status of Citco Station located on Highway 157. Mr. Saint informed the Council that ownership has not been decided. Cassandra Lee questioned ownership and removal of the charity collection boxes located in the Foodland parking lot. Mr. Saint will investigate further to determine what action may be taken. Brent White thanked Mr. Saint for the report and reminded the Council that any enforcement of the Nuisance Ordinance that requires funds being spent for demolition will require a vote of the Council. Mr. Saint stated that he will request review of ordinance by the City attorney to ensure proper procedure of demolition is followed.

Motion to adjourn was made by Denise Lovett and seconded by Brent White, with all voting in favor.
