Mayor Weatherwax called to order the meeting and ask for a motion to dispense reading of the minutes for March 26, 2018 and approve them. A motion to this affect was made by Jason White and seconded by Joyce Jeffreys, with all in favor.

Tricia Bobo with the Liberty Learning Foundation was recognized by Mayor Weatherwax and made a presentation to the Council. Ms. Bobo is part of this Foundation which goes into the school systems with a program to educate 2<sup>nd</sup> graders and in some areas 5<sup>th</sup> graders through different avenues to the importance of Civics. After her short and informative presentation she ask that the Council consider making a donation to the Foundation to help with their endeavors. Brent White posed the question to her if the school system was a sponsor and they are not because this is something that is done for them. Other council members were in support of the idea of what they do but the question was also posed if it would be any reasons that could preclude the City from being able to sponsor such a project so the League will be contacted to get answers concerning that question and Council will take all matters into consideration.

At the previous meeting Jerome Thompson had presented to the Council the need to appoint members to the Medical Clinic Board of Moulton and had made suggestions of Patsy Lang, Tim Littrell and Christy Graham for the Council to consider for those appointments. Mayor Weatherwax ask that the Council consider those recommendations and if anyone had any discussion to let it be heard. With no discussion on this matter a motion to appoint all three of these recommendations to the Board were made by Brent White and seconded by Jason White with all in favor for the appointees to the Medical Clinic Board of Moulton.

Mayor Weatherwax ask that City Clerk, Deroma Pepper explain the options of the insurance changes. Deroma Pepper had a breakdown of the two options for them to consider Option #1 was to stay with the Plan that the City currently has which would be increasing and Option #2 would be to change plans with a little change in deductibles and cost would go down. Jason White ask if we could consider the plans and try to do whatever the City could to help the employees even though it might cost the City more. Brent White agreed that if possible the City should help the employees with cost. Council members will consider the plans and discuss further at the Work Session. No vote was taken at this time.

With no further business a motion to Adjourn was made by Denise Lovett and seconded by Jason White.
