Mayor Weatherwax called meeting to order and ask for a motion to dispense reading of the minutes for April 2, 2018 Council meeting and April 9, 2018 work session. A motion to this effect was made by Joyce Jeffreys and 2nd by Jason White.

Jackie Burch had requested for council approval to purchase a lawn mower for the park due to one that normally was being used was unable to be repaired. There were two options that the Mayor had presented to the council in an earlier work session. The first option was for a Toro - 2013 72" out-front mower from Jerry Pate for approximately \$14,000.00 with a 30 day warranty which they thought would last at least 10 years or to purchase a new mower 2018 - 72" for \$21,000-\$22,000 by using the state bid law. After much discussion the motion was made by Cassandra Lee to purchase the 2013 mower for the approximate amount of \$14,000.00 and the 2nd to the motion was made by Denise Lovett.

Patricia Morgan had request permission to attend the AMMCCMA Annual Conference September 19 – 23 in Perdido Beach for required hours of training. Jason White made the motion for her to attend and Joyce Jefferys 2nd the motion.

Mayor Weatherwax presented the Council with a resignation letter from Teri Dutton with last day being April 26, 2018. Due to this there will be a posting of the Accountant job internally first for 5 days and if no one is found then for 2 weeks an ad will be placed in the Moulton Advertiser for applicants to fill this position.

The Employee Insurance is an item that has to be discussed usually yearly and so as in the past a decision had to be made and after much consideration of the options. 1) Keep old plan and all premiums increase and decide how to distribute the increases between each option and the City and employee 2) Change plans which would have some changes to benefits – mainly increases in deductibles and reduce cost to City and some employees. The motion was made by Jason White to choose option #2 and save the employees that would be effected money and also save the City money with no more changes in benefits that the new plan would make. The motion was 2nd by Joyce Jeffreys.

With no more business to be discussed a motion was made by Denise Lovett to adjourn and it was seconded by Joyce Jeffreys.
