Mayor Weatherwax began meeting asking for a motion to dispense reading of the minutes for May 21, 2018 and to approve them. A motion was made by Joyce Jeffreys to accept minutes and forgo the reading of them. A second was made to this motion by Jason White.

The Masonic Lodge requested permission to do a roadblock at Court Street and Hospital St on June 9, 2018 from 9:00 am until 1:00 pm. Joyce Jeffreys made the motion to allow for this and a second was made by Brent White.

Keisha Davis requested if necessary for extra time off for unpaid leave due to recovery from a medical procedure she is to have, since she has used all of her accrued vacation & sick time. Jason White made the motion to allow her the extra time if necessary and a second was made by Denise Lovett.

A presentation was made by Stacey Givens representing Superior Mosquitos in reference to the mosquitos at the mini park and other areas in the City. He presented the Council with a cost for the treatment that the company does in a season to the Council and ask that they consider it. Cassandra Lee ask if the McKelvey Park could also be included in the efforts to control mosquitos due to children also playing in that park and area. After a brief discussion the Council decided to ask him to do a cost for several areas in town to include but not necessary limited to the McKelvey Park, the Alexander Park and walking trail along with the cost estimate for the Mini Park and Splash pad area. Discussion on this matter will be handled at a later date.

Fire Chief Ryan Jolly spoke with the Council concerning the job descriptions of Assistant Chief and Fire Captain and the need to approve a pay scale for these jobs. A motion was needed to accept the purposed pay scale of 7A for Fire Captain and Assistant Fire Chief as Grade 9. A motion to accept the Grade 7A pay scale was made by Brent White and seconded by Denise Lovett. A motion to accept the Grade 9 pay scale for Assistant Fire Chief was made by Brent White and seconded by Jason White.

City Clerk Deroma Pepper ask for a Pay Grade change to the Accountant position from a Grade 7 to a Grade 8 due to the complexity of the job. After some discussion on the matter a vote was taken with a

motion being made by Jason White to make this change and seconded by Denise Lovett, all members of council voted in favor of the change.

A motion to adjourn was made by Denise Lovett after there was no more business to discuss. A second was made by Brent White.
