Mayor Weatherwax began meeting asking for a motion to dispense reading of the minutes for June 11, 2018 and to approve them. A motion was made by Jason White and seconded by Joyce Jeffreys.

Callie Waldrop introduced to the Council that Ordinance #2016-006 Diversion Ordinance needed to be amended to include two new Acts one which requires interlock devices and the other which is a fee of \$100.00 to be paid to the Alabama Head & Spinal Cord Injury Trust Fund. Motion to make these changes came from Brent White and was seconded by Joyce Jeffreys.

Superior Mosquito Defense had presented the Council with a bid to spray the Mini Park at a previous meeting. A motion was made by Brent White and seconded by Jason White to allow them to treat the Mini Park for one season and that Jackie Burch would monitor the activity of the pest and report if there was enough effect that it would benefit to do again and to include the KC McKelvey Park and possible other areas or not to do because of the effects no being noticed. Cassandra Lee said that she would like to have a report back from Jackie after the process and to make sure and revisit adding the KC McKelvey Park if it is efficient next season.

Council members approved for Lyndon McWhorter to attend the Chiefs Conference and Training in Gulf Shores July 30<sup>th</sup>-Aug 2<sup>nd</sup> by a motion made by Brent White and seconded by Jason White.

At a previous meeting Fire Chief Ryan Jolly had requested that the pay scale be updated to include Grade 7A and steps in order to utilize the Job Description of Captain. At his request Brian Phillips was promoted to Grade 7A Step 4 with the motion being made by Cassandra Lee and seconded by Jason White.

A motion was made by Jason White and seconded by Brent White to open up a job posting for a Maintenance Worker at the Park & Rec Dept per request of Jackie Burch. The job will post internally for one week and if no interest from within then will be posted in newspaper for 2 weeks.

During a recent work session Jackie Burch introduced the idea of moving the playground at the HA Alexander entrance to the ballfield to just past the concession stand. A motion to allow Jackie to advertise for a proposal for bids for this work to be done was made by Brent White and seconded by

Jason White. It was questioned by Joyce Jeffreys where the funds for this to be completed would come from and she was reassured that the Concession Stand money would cover the cost of the project.

Upon agreement by Council to finish the fencing and dugouts at the new ball fields a motion was made by Joyce Jeffreys and seconded by Jason White for Jackie Burch to obtain a Request for Proposal to get cost to finish this part of the project.

A motion to Adjourn was made by Brent White and seconded by Joyce Jeffreys.
