Meeting was called to order by Mayor Weatherwax followed by pledge and prayer.

The Meeting was opened by Mayor Weatherwax to a Public Hearing to discuss the City's submission of an application for the PY 2020 Community Development Block Grant (CBDG) program. Dan Yurcaba was there on behalf of Narcog to answer any questions and present the Council and public with information on this grant application. The funds would be used by the sewer department to rehabilitate sewer valves near the elementary school and south of City Hall. The City had a flow study done earlier that addressed the most needed areas due to inflow of water to the sewer system. The City is eligible for this grant due to the population and with a 10% match of funds. Mr. Yurcaba spoke briefly of the different grants and the funding available for submittal. After hearing the presentation of those present there were no questions that were not answered in full to the grant and conditions.

Mayor Weatherwax closed this part of the meeting to continue on with the regular scheduled Council Meeting. Council were ask to dispense of the reading of the minutes for March 18, 2020 and approve them.

Budget wise we still are ok but next month will tell us more on the effects that will impact the City if any. Ms. Farris advised Council that we could possibly be reimbursed for some of the additional cost incurred due to COVID and that we were doing everything that could be done to recoup any additional monies.

Cassandra Lee was not originally on the agenda but was added by Mayor Weatherwax at her request of a Resolution. Ms. Lee wanted answers to the ongoing Sidewalk project and answers to why it had not progressed along as it had been in the works for approximately 6 years. Mayor Weatherwax addressed Ms. Lee and said that it had been put on hold due to the COVID-19 occurrence.

Mayor Weatherwax gave a brief update on the Park and Recreation Department that the Softball was not going to be played, T-ball was not going to be played and Baseball was to have a meeting on Tuesday night to decide if they would play.
