CITY OF MOULTON COUNCIL MEETING July 20, 2020 @ 5:00 PM

Meeting was opened by Mayor Weatherwax leading the pledge followed by prayer lead by Brent White.

The first item on the agenda was the Public Hearing on the DWSRF Loan for Infrastructure Rehabilitation for the Water Department --- this was conducted by Kelley Taft from the Kelley Group. Ms. Taft made those present aware that the City of Moulton had been awarded a true \$500,000.00 grant and another \$500,000.00 at 2% fixed rate for 20 years. She also spoke on the additional funding that will possibly be available for next year. The Kelley Group has been instrumental in doing a water study for a 10-year improvement plan that will help in the decision process of where to utilize the funds.

Following the Public Hearing Mayor Weatherwax ask the Council to approve and dispense reading of the minutes for the July 6, 2020 Council Meeting and July 13, 2020 Work Session.

A change order for additional cost due to the decision to change out the idle meters that were not included in the original bid for the meter change out project in the amount of \$48,046.80 needed approval by Council. Kelley Taft explained that this was also needed to help with the study completion of the water loss for upgrades.

There were some risers that needed to be used also in the water meter project to move the meters up to make them more accessible that were not included in the original bid. The additional cost of \$765.00 needed approval for these installations.

Jay Johnson spoke to Council about his concerns and need to purchase a new alum tank and pad for it to be placed on. The current alum tank is on the roof of the treatment plant and is gravity fed to treat the water. This new tank would replace that one and be more efficient. The cost for the Tank will be \$13,500.00 and the concrete pad would be \$1,500.00. Mr. Johnson had originally as that this be in his budget for the 2020-2021 year but due to the timing it would be more sensible to do this at this time since the alum is due to be ordered soon.

Originally when the Gas Meter project was bid Mike Hand had thought that the City Gas workers would install the change outs on the Commercial meters but after the project progressed it was decided to let the contractors to that work. The materials for this Change Order #1 for the Gas Meter Project in the amount of \$19,360.00 needed approval and bond money is still available to cover this change.

Ingram Equipment Company, LLC made repairs to the Garbage Truck while in for repairs in the amount of \$23,089.18 and needed Council approval.

Our Boom Truck also needed repairs in the amount of \$5,487.87 as indicated on requisition #02369 and needed approval.

Quality Paving had two invoices in need of approval #02367 for the Street, & Water Depts in the amount of \$9,259.50 and #02368 – additions made by the Sewer Dept.

Before Jackie Burch retired the Council had approved to spend up to \$50,000.00 more on the new ballfields. Rogers Group has an invoice of \$17,696.46 for the rock in the parking lot that needed approval. According to Emily Edwards the Sitework/Dirt Work was \$32,155.00 & TOPO Survey of \$4,100.00 for a total of \$36,255.00 being spent of the \$50,000.00 so this invoice would go over the \$50,000.00 by \$3,951.46 and the Council was ask to approve the difference.

Musco Finance had purposed a Lease agreement for the lighting materials only at the State Bid price so this didn't have to be bid out. Payment will be up to \$3,090.00 for at least 12 months with the option to pay in full without penalty anytime thereafter to get lighting attached to the poles to be erected.

Bids will be opened on August 6, 2020.
