Meeting was called to order by Mayor Weatherwax followed by pledge and prayer.

Cassandra Lee also expressed concern about the matter and ask if the City would get any monies given back if it was found that it was not quality food being prepared. Cassandra Lee ask that it be noted in the minutes her concerns and again if the City would receive any monies given back if it was found not to be satisfactory food served. Joyce Jeffreys said she was in favor of giving the money. Mayor Weatherwax stated that since the Strawberry Festival wasn't able to be held last year that the money given for that to the Lawrence County Chamber of Commerce should be used for the Lawrence County Center on Aging request.
