Blake McAnally was present to address the Council on his proposal for the engineering firm Pugh Wright McAnally to professionally design, survey, do civil engineering and architectural services for phase II improvements to travel baseball park located at HA Alexander Park. (see attachment) 5R Design, P.C. would also be responsible for the Architectural Bldg and field lighting design scope. Mr. McAnally explained the process to Council and ask that permissions be given to start this process due to this is the next step in moving forward with the ballfields. Total cost for his services will be \$92,332.00 of which details are given in attachment. Council had several questions in which Mr. McAnally answered their concerns and reassured them that should they decide not to move forward with the project after his services are complete then it could be put on hold that would be up to Council. Once this is complete it can be let for bids which they also can take care of and his best guess was if everything proceeded as he thought and weather was in the Cities favor then by Spring of 2022 the fields could be ready for play.
