Resolution 2022-017 Cemetery Plot & Opening and Closing Increases this will be effective as of January 1, 2023 the price will go up to \$1,900.00 from \$1,800.00 and on January 1, 2024 the cost will increase to \$2,000.00 these increases will include opening and closing. For those who have to pay opening and closing only due to previously purchasing plots before opening and closing was included will now as of January 1, 2023 be \$500.00.

SCADA bids were opened on October 11, 2022 at 1:00 PM. The one bid received from Williams Electric and Line Construction, Inc. in the amount of \$338,170.00. During the bidding window there were 3 locations that received damaged during storms in which the Cities insurance covered the repairs. Those repairs were part of the original bid so those items were removed from the base bid resulting in a total deduction of \$81,020.00 from 3-line items which results in the final base bid award amount being \$257,150.00. The Kelley Group makes a recommendation to award the Water system SCADA Improvement project to Williams Electric and Line Construction, in the amount of \$257,150.00.

on the contingency of the Alabama Department of Environmental Management letter approving and authorizing the City of Moulton acceptance of bids. (SRF funds will be used to pay for this)
