Blue Cross Blue Shield insurance rates had an increase and needed the Council to approve how the City was going to handle the increase. The Council was presented with the current amounts where the City pays 60% and the employee pays 40% except on Employee only where the City pays the entire cost. The Council was also given the rate increase amounts for each level and figured at the same rates along with the percentages of 65% for City and 35% for employees for the new rates. Craig Knight spoke on behalf of his department and ask that the City consider another plan or paying more because one of his employees' spouse had given him just prior to the meeting the rates that employees at Trinity have to pay for Blue Cross Blue Shield (Local Government Insurance). Council member Jason White ask if we had checked into other plans and Deroma Pepper, City Clerk stated that she had and that the Council had that information in their packets also

where she had checked on Local Government Rates, which were higher. Council member Cassandra Lee ask if someone could come and speak to the Council about the rates and plans. Ms. Pepper stated that the renewal was June 1, 2023 and that a decision needed to be made soon. Ms. Lee ask for a Work Session to be held the following Monday and to have representatives at the meeting to give information to the Council. Mayor Weatherwax said there would be a Work Session the following Monday and that the agents would be contacted to be present to answer questions if possible.
