Ryan Jolly, Fire Chief presented the Council with the proposal that bids be taken again for the Turnout Gear because the bids they had original received either came in over budget or didn't meet the requirements in the bid specifications, so he will go through the bid process again based on the consciences of the Council. In other business he ask that the Council consider looking over the job descriptions that were adopted in 2006 for Fire Captain and assign a pay scale Grade of 7 rather than a Grade 6 since their wasn't one made at the time of adoption. Discussed also were the other positions in the Fire Department: Assistant Chief (which also needs to be assigned a pay scale), and Firefighter.

Jackie Burch, Parks & Recreation Director spoke about the architect from Goodwyn, Mills and Cawood coming and giving a more accurate cost estimate for the projects purposed at the new ballfields and surrounding areas: Cost estimates were higher than originally thought by more than \$150,000.00 for Control Building and Dirt work estimate was also higher by approximately \$5000.00. Mayor Weatherwax gave information to Council Members about possible cost for financing the project at different variables and they will take all new information into consideration. Several members voiced that they didn't want to dedicate all alcohol monies to this project at this time due to the financial straits that several surrounding communities are in and the fact that the City has other projects that may be necessary but cost are unforeseen.

Brent White ask the members to consider the bill SB31 before the legislation and whether or not they need to in act a resolution against the bill to show their opposition to the contents therein.

Mayor Weatherwax ask if there was any more business, and briefly a discussion about the Lawrence County Solid Waste was still in process of getting paperwork approved to become the dumpster provider for the City. David Cannon with Republic ask if he could speak and present information to the council about how they could would benefit from not changing the way dumpster service is provided to businesses now. Mayor Weatherwax allowed him to speak to Council and give handouts that can be considered before decisions are made on a contract.

Brent White ask if council could go into executive session due to "Good name and Character."

The council voted all in favor to go into executive session at 5:55 pm and left the Council Chambers to convene in the smaller conference room at City Hall. The session ended at approximately 6:35 pm with Council returning to Council Chambers.

With no further business the motion was made by Brent White to adjourn and was seconded by Denise Lovett.
