All elected officials were present.

Darrell Brewer with Alabama Rural Water Association was present to explain the need to increase the Wholesale Water Rate. The last rate increase was in the year 2020. The rate increase before that was in the year 2008. The current contract set to expire in the year 2037 has a set rate of \$1.19 per 1000 for the first 5,000,000. The current rate for water in excess of 5,000,000 is \$1.90. According to the most recent study for the City of Moulton Water Department there is a present loss of .87 cents per 1000 gallons. The study recommends a rate increase to \$3.35 per 1000 gallons above 5,000,000 beginning with the next billing cycle. The wholesale customer was notified November 2024 that the increase was necessary. The wholesale customer has notified their customers of a pending rate increase.

Resolution 2025-004 Lien to be placed on the property located at 14321 Court Street in the amount of \$52,532.61 for the cost incurred by the City to abate the nuisance on this property. The property owner refused to comply.

Resolution 2025-005 Re-appointing Kay Walker and Keith Gilley each to another term on the Planning Commission. Each term is a six-year term expiring February 3, 2031.

Resolution 2025-006 City of Moulton Cemetery Lots to increase in cost per lot from \$1500.00 to \$1600.00 each for the year 2025 beginning March 1, 2025 and for the future cost of a lot to increase by \$100.00 annually. **Resolution 2025-006** also provides for the gravesite opening and closing cost to increase from \$500.00 to \$600.00 beginning March 1, 2025 with an annual increase in cost for opening

and closing to be adjusted by \$200.00 above the contractor's cost for opening and closing of a gravesite. All future annual increases will occur on January 1st.

Permission from Council to let bids for the maintenance and lawn care of the Moulton Memorial Garden Cemetery for a period of one year. If approved the required bid posting will be made and also posted in the Moulton Advertiser.
